

“2018 Roxy Quiksilver” Sweepstakes

Official Rules

NO PURCHASE NECESSARY. OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND DISTRICT OF COLUMBIA, PUERTO RICO 18 YEARS OF AGE OR OVER. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Sweepstakes Period: The “2018 Roxy Quiksilver” Sweepstakes (the “Sweepstakes”) begins at 11:59 p.m. Eastern Time (“ET”) on April 26, 2018 and ends at 11:59 p.m. ET on May 31, 2018.

2. Eligibility: The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, and Puerto Rico, who have the age of majority in his/her state of residence as of date of entry. Employees of West Marine Products Inc., 500 Westridge Drive, Watsonville, CA 95076 (referred to herein as the “Administrator”, “Sponsor” or “West Marine”), their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies (collectively “Sponsor & its Administrators”) and the immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each, are not eligible to participate or win. Once submitted, an Online Entry cannot be deleted, canceled or modified. Online Entries must originate through www.westmarine.com/sweepstakes to be eligible. Enter using only an e-mail address subscribed and registered in your name. In the event of a dispute as to Online Entries submitted by multiple individuals using the same e-mail account, subscriber is deemed to be the natural person who is assigned an e-mail address by an Internet access provider, online service provider or other organization which is responsible for assigning e-mail addresses or the domain associated with the submitted e-mail address.

Sponsor is not responsible for delayed or late deliveries of Entries, Entries lost, misdirected or otherwise misplaced in the mail or Entries not otherwise received regardless of reason.

C). To Enter By Mail: To enter by mail, without purchase or obligation, send your name, address, city, state, zip code and day and evening telephone numbers with area code hand-printed on a 3-1/2" x 5" piece of paper to: West Marine "2018 Roxy Quiksilver" Sweepstakes, 500 Westridge Drive, Watsonville, CA 95076 ("Mail Entry"). Mail Entries must be postmarked by May 31, 2018 and received by June 6, 2018. Sponsor is not responsible for delayed or late deliveries of Entries, Entries lost, misdirected or otherwise misplaced in the mail or Entries not otherwise received regardless of reason.

The Grand Prize package has an Approximate Retail Value ("ARV") of \$1,500. The Grand Prize package pool is \$4,500.
