

**Warranties**

Warranty start dates are based on first purchase date of the boat. The warranty begins at the time of purchase. Refer to the warranty card that is with the boat for specific warranty details. Warranties are non-transferrable and apply to the original customer purchase only.

In general, the warranty coverage on boats is as follows:
